GENERAL INFORMATION, TERMS AND CONDITIONS.

COSTS:

*Cost for the tour would be using 5 star hotel in Delhi, Exclusive Resort property at Rishikesh & 5 star hotels in Agra & Jaipur. US\$ 3990 per person on double occupancy. US\$ 5420 per person on single occupancy. If you are traveling alone and wish to share accommodation, we will match you with a roommate if available. If none is available or if you prefer a single room, a single supplement fee will be applicable.

Cost includes: Accommodation with morning buffet breakfast in Delhi and with all three meals* at Rishikesh. (* vegetarian) All transportation, transfers, sightseeing and excursion by private mini coach. Return train tickets for:- Delhi-Haridwar-Delhi in air-conditioned coach. Services of English speaking escort in Delhi and Agra. Services of personal Yoga experts for the group. Excursion tours as per the itinerary. Entrance fees to the monuments as per the itinerary. All current taxes.

Cost does not include: Insurance, Any item not specifically mentioned in the itinerary. Any items of a personal nature, travel insurance, additional expenses resulting from the delay or extension of a trip due to weather, political disputes, sickness or other causes beyond our reasonable control. Tipping your driver and guide at the end of the trip is normal, but entirely at your discretion.

CANCELATIONS/REFUNDS:

- An amount of US\$500 – is paid on registration, which is non-refundable in case of cancellation.
- We accept registration on the spot through credit card/money transfer/bank draft.
- Payment due date: 2 months before the commencement of the tour.
- By cancellation 2-3 months before tour-start 75% of the total amount will be refunded.
- By cancellation 2-1 months before Tour-start 50% of the total amount will be refunded.
- By cancellation 1 month or less - no refund.
- Also, in case of refund - the money transfer charges would be borne by the participants.

CANCELLED TRIPS: Damask Rose Tours reserves the right to cancel any trip due to inadequate sign-up, which makes the trip economically infeasible to operate. Notification will be given at least 30 days prior to departure. A full refund will be given or you may choose to transfer to another tour. If the full payment is not received 8 weeks before the tour date departure, your place on the tour will be automatically cancelled and given to someone on the waiting list.
